WHEREAS, Administrative Order No. 2.063 In re: *Uniform Bond Schedule* includes a schedule of bonds, fines and costs; and

WHEREAS, it is expedient to establish a schedule of bonds to facilitate the pretrial release of those persons taken into custody and to also allow those charged with Conservation and State Park violations the ability to plead guilty and pay their fine without a Court Appearance for various violations; and


WHEREAS, the court costs were incorrectly calculated on a majority of the schedules;

NOW THEREFORE, it is ORDERED:

Administrative Order No. 2.063, In re: *Uniform Bond Schedule* is hereby amended to reflect the correct court costs and renamed In re: *Uniform Bond Schedule and Conservation & State Park Guilty Plea Schedule*.

Administrative Order No. 2.063/08-1 shall take effect upon the date of execution and will replace Administrative Order 2.063 and all schedules in its entirety.
